Bidders must satisfactorily submit, in triplicate, all required documents, mandatory compliance certifications, and the Bid Form at the time of Bid opening for the bid to be considered responsive.

The Contractor Agreement (“Contract”) will be awarded to the lowest responsible Bidder whose Bid conforms in all material respects with the terms and conditions of the Bid and Contract Documents. NJEDA reserves the right to deny award to any Bidder that is not clearly responsive, based upon the criteria set forth in the Bid documents.

Remittance of a non-refundable payment of \$100.00 made payable to the New Jersey Economic Development Authority is required for each set of hard copies.

The Project consists of the abatement and demolition of Building No.'s 2700 and 2705 and site features which are located on the former Fort Monmouth Army Base at the intersection of Corregidor Road and Pearl Harbor Road in the Borough of Tinton Falls, Monmouth County, NJ.

All bidders are encouraged to thoroughly inspect the buildings and site prior to submittal of the Lump Sum Bid Prices in accordance with the Contract Documents. The buildings are open for inspection Monday, July 10, 2017 through Friday July 14, 2017, between the hours of 8:30 a.m. and 5:00 p.m. Bidders are required to first check in at the Building 2700/Myer Center building entrance located on Laboratory Road to receive, sign and submit the Hold Harmless Agreement. Hard hats and flash lights are required for entry into the buildings.

All respondents and their key subconsultants may visually inspect the site at their own risk. All entrants must demonstrate their agreement to hold the NJEDA harmless by signing the Hold Harmless Agreement (see Section 8.0, Rider B – Additional Documents) prior to their inspection of the site.

In lieu of designating this a mandatory prime contractor set aside contract, NJEDA is designating this as a subcontractor target program contract, and NJEDA will require the selected Contractor to make a good faith effort to award 25% of the dollar value of the contract to eligible small businesses, pursuant to N.J.A.C. 17:14-4.3, and as outlined in Section 11 of the Bid Documents.

Bidders are encouraged to carefully review the Contract in Section 4 of the Bid Documents. Questions regarding the Contract and any proposed modifications to mandatory requirements of this Invitation to Bid must be posed during the questions/clarifications period set forth above and should contain Bidders' suggested changes. NJEDA, however, is under no obligation to grant or accept any changes to the Contract. By submitting a proposal in response to this Invitation to Bid, Bidders agree to be bound by the terms of the Contract and any revisions, if applicable, outlined in the final Questions and Answers. Exceptions to or questions regarding the Contract received after the Question and Answer period will not be considered.

Any Bid submitted in response to this Invitation to Bid will be considered a Firm Offer by the responding contractor to perform the Scope of Services, as outlined in the Bid Documents. By submitting an Offer in response to this Invitation to Bid, the responding Bidder agrees to hold its Offer open for at least 90 days after the response due date. Any provision in a submitted Offer that attempts to limit or condition the time that an Offer is open for consideration by the NJEDA will not be binding on the NJEDA. NJEDA, in its sole discretion, reserves the right, upon written request and good cause shown to the satisfaction of NJEDA's staff, to allow a responding Bidder to withdraw its Offer after Offers have been opened. Execution of the Bid Form indicates acceptance by Bidders of the form of the Contract.

All Bidders are required to comply with the requirements of P.L. 1975, c.127 – N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq.
