Annual Report 2003-2006**

I. Overview

The New Jersey Economic Development Authority (EDA) is pleased to report the results of its activities for calendar years 2003 through 2006 under the Local-State Business Incentive Promotion Act (the “Act”), in accordance with P.L. 1998, Chapter 94. This report reflects activity for the period January 1, 2003 through December 31, 2006.

The EDA is an independent, self-supporting State entity dedicated to broadening New Jersey’s economic base by building vibrant, diverse communities, creating and maintaining jobs and providing businesses and nonprofits with the necessary financial and technical support to grow and succeed. Since its’ inception in 1974, the EDA has assisted more than 9,220 businesses and not-for-profit organizations through more than \$18.4 billion in financing support.

In offering a wide range of financial, real estate development and technical services to encourage business growth and job creation, the EDA has successfully advanced business retention and attraction efforts in communities throughout New Jersey. Specifically, the EDA has established several funds to implement the intent of the Local-State Business Incentive Promotion Act, including, among others, the Local Development Financing Fund (LDFF) and Fund for Community Economic Development (CED).

Along with the assistance provided through these funds, the EDA directs other financing, business incentives and tax credits to local businesses which, in 2006, totaled \$672.4 million supporting new public/private investment of more than \$1.8 billion and is expected to result in the creation of over 15,800 new, full-time jobs and nearly 7,200 construction jobs.

The EDA also continued its efforts with local, county and state partners to leverage resources and assist local development projects through local/regional economic development organizations, chambers of commerce and business organizations and the private banking community. Utilizing the Internet and paid advertising, the EDA has aggressively marketed the availability of its services and products to reach existing and potential businesses in every region of the state.

In 2006, the EDA made significant financial commitments to the creation of the Edison Innovation Fund and the New Jersey Urban Fund to support technological innovation and neighborhood revitalization in 2007 and beyond.

In the future, the EDA will continue to advance these important economic development initiatives along with other major efforts, including Special Improvement Districts and Redevelopment Area Bond (RAB) financings, to further achieve the goals of the Local-State Business Incentive Promotion Act.

II. Update of Activity 2003-2006

In 2003-2006, the EDA financed over \$1,642,077,496 in loans, loan guarantees, bonds and Business Employment Incentive Program (BEIP) grants to 401 projects, which advanced the intent of the State-Local Business Incentive Promotion Act. *A list of all projects assisted is attached.*

Under support for these projects, the EDA helped promote business activity stimulating over \$3,931,112,242 in total project costs and creating an estimated 10,300 new jobs, as illustrated in the program chart below.

The following highlights projects financed through key funds, as well as other regular EDA assistance, offered in support of the Act.

III. EDA Programs Used to Accomplish Goals of the Act

Local Development Financing Fund (LDFF)

The Local Development Financing Fund (LDFF) provides loans ranging from \$50,000 to \$2 million to commercial and industrial projects located in Urban Aid municipalities for fixed assets such as buildings and equipment.

From January 1, 2003 to December 31, 2006, 44 projects were funded through the LDFF, for a total of \$24,146,950 averaging approximately \$548,794 in total financing per project.

One of the projects funded under the LDFF was a \$770,000 low-interest loan to Pecaso Realty, LLC, and a real estate holding company, to purchase an 88,000 square foot building on North Broad Street in Hillside, New Jersey. The building provided a home for Pecaso's Picasso Lighting, Inc, affiliate, a manufacturer and wholesaler of crystal chandeliers and high-quality lighting systems.

With the expansion, the former Brooklyn, NY business was able to employ 72 people, more than 20 of which were added as a result of its New Jersey expansion. The EDA loan was part of the funding for the \$3.6 million project, which is also being financed with a \$1.5 million loan from Banco Popular and more than \$500,000 in equity.

Fund for Community Economic Development (CED)

The Fund for Community Economic Development (CED) serves as a statewide network of public and private resources committed to providing a source of flexible financing to support community economic development initiatives in New Jersey's urban centers. The CED, which focuses on projects located in urban areas which are sponsored by community development organizations and which will result in employment of local residents, is capitalized through the private investment of PSEG and JCP&L/First Energy Corporation.

From January 1, 2003 to December 31, 2006, 15 projects were funded through the Fund for Community Economic Development, for a total of \$4,172,563 averaging approximately \$278,170 in financing per project.

Under the CED, a \$40,000 EDA predevelopment loan was used to finance a feasibility study for the New Jersey State League of Municipalities to renovate the historic Roebling Mansion, located within the State House District, for its new headquarters. Nearly \$1.4 million in low-interest EDA loans and a \$3.6 million Wachovia loan under the federal New Markets Tax Credit program provided permanent funding for the \$5 million project. Additionally, a \$750,000 Capital Preservation Grant helped fund the restoration and preservation of the building, which is on both the state and national Registers of Historic Places.

Redevelopment Area Bond Financing (RAB)

The EDA issues long-term, low-cost bonds on behalf of municipalities seeking to fund infrastructure improvements and other new development costs. Under the Redevelopment Area Bond Financing (RAB) Law (NJSA 40A:12A-64 et seq.), a municipality that has designated a redevelopment area may, either directly or through application to the EDA, issue tax-exempt bonds to fund the infrastructure and remediation portion of its project. The bonds are backed by Payments in Lieu of Taxes (PILOTs) that are negotiated between the municipality and the developer and pledged to pay the debt service on the bonds. Municipalities may enter into financial agreements with redevelopers exempting the improvements from taxation, whereby the property owner agrees to pay an annual service charge for municipal services under the PILOT program.

The City of Newark approved a redevelopment plan and a redevelopment area pursuant to the Local Redevelopment and Housing Law (NJSA 40:12A-1), which included a vacant, 37 story office building located at 1180 Raymond Boulevard which will be completely renovated and converted into a mixed use project, The Residences at Lefcourt Tower, consisting of 317 market rate rental units, and approximately 22,000 square feet of commercial space.

In 2006, EDA approved \$7.9 million in RAB financing that will enable the City of Newark to assist in the financing of a portion of the redevelopment of the project site by 1180 Astro Urban Renewal Investors, L.L.C. The bonds will be repaid from PILOT payments made by the redeveloper and enabled by tax abatement on the property, pursuant to the RAB Law and pledged by the City to bondholders. The EDA bonds helped the City of Newark leverage a total of \$109 million for the project, which will support the revitalization of the downtown area and generate new growth through the creation of new residential and commercial space into the designated redevelopment area.

Special Improvement District – Newark Downtown District Management Corporation

The Newark Downtown District Management Corporation (NDD) was established by an ordinance passed in September 1998 by the Newark Municipal Council to revitalize downtown Newark by improving the economic viability of the central business district and enhancing the quality of life for residents, workers, students and visitors through supplemental services, marketing and physical improvement programs.

In 2006, the EDA approved \$10 million in tax-exempt bonds to support the NDD Streetscape Improvement Project, intended to change the appearance and perceived attractiveness of downtown Newark for every single block within the district, rather than a few well-traveled arteries. The NDD project includes decorative street lighting, enhanced corner sidewalk treatments, granite curbing, large and visible street signs, street trees, planter boxes and plantings, tree pits and news racks for local/regional daily newspapers and free weekly papers. Nutria Alley would also be established to create a vibrant, open-air marketplace, as well as relocating existing street vendors. By improving the visual appeal of the District, new tenants can be attracted, and existing tenants will be encouraged to remain. Over time, the resulting demand for rental space in the District will create higher values for the District's properties, eventually leading to higher tax revenue for the City.

Special Improvement District (SID) assessments are collected from the property owners in the Newark Downtown District by the municipal government of Newark and disbursed to NDD. These SID assessments will be used to pay debt service on the bonds. The difference between the maximum amount of the bonds and total project costs is to be funded by UEZ Funds and City of Newark In-Kind Payments through PSE&G.

IV. EDA Partnerships

Office of Economic Growth (OEG)

The EDA has partnered with the Office of Economic Growth (OEG) on major efforts to promote economic development in New Jersey, including formulating Governor Jon S. Corzine's Economic Growth Strategy. More information on the Strategy can be accessed at the New Jersey Business portal at www.state.nj.us/njbusiness/.

Action Council on the Economy (ACE)

The Authority also is an active partner in the Action Council on the Economy (ACE), established by the OEG and composed of representatives of more than 23 state departments, commissions and authorities, to respond proactively and in a coordinated manner to economic development issues and opportunities. The ACE subcommittees, formed to implement the Governor's strategic priorities for economic growth include: Information Technology Subcommittee, Small Business Technical Assistance Subcommittee, Port Subcommittee, Urban Economic Development Subcommittee, Route One Subcommittee, Brownfields Subcommittee and Ready for Growth Subcommittee.

Entrepreneurial Training Institute (ETI)

The Entrepreneurial Training Institute (ETI) is an innovative program that assists aspiring and new entrepreneurs in developing necessary step-by-step plans for their own businesses. The

highly structured program offers multiple levels of technical assistance, including: free, web-based self-assessment; free information workshops with local and regional partners; practical training on preparing a focused business plan, understanding the financial aspects of running a small business and developing marketing strategies; feedback from professionals; introductions to financing opportunities; and, on-going advocacy and mentoring services.

ETI is offered in the spring and the fall each year in 10 to 12 locations throughout the state. Since 1992, more than 1,200 individuals have graduated from ETI, including 20 students in 2006 and ETI graduates have received more than \$26 million in financing assistance from banks, the NJDA, and other sources of funds to start and grow their businesses. Over the program's 14 years, more than 100 banks, lending institutions, organizations, corporations, educational facilities, and other advocates for small business throughout New Jersey had forged strong partnerships with ETI, and were actively engaged in supporting the efforts of ETI alumni. The alumni receive newsletters, informational emails based upon their business type, free promotion in the Alumni Directory and a contact for questions and referrals.

Business Mentoring

Nearly five years ago, the EDA teamed with several of New Jersey's premier business development organizations to offer a Small Business Mentoring Program. The program now provides "post-graduate" services to students who complete ETI. With the help of the Mentoring Program, new business owners gain a partner to assist them in facing and overcoming the obstacles they typically face as they begin their new venture. In addition, the Mentoring Program also benefits the recipients of micro loans obtained through the sponsoring organizations.

In 2006, Jamie Burr, a graduate of the ETI program, benefited greatly from his business mentor who helped prepare a financing request that resulted in a loan totaling \$1.3 million in combined funding from the EDA and PNC Bank, to assist in purchasing a facility to house his uniform business in Newark. With the help of a business mentor, Malachi Washington, Jr. received \$30,000 in combined financing from the Cooperative Business Assistance Corporation (CBAC) in Camden and The Bank to open his truck repair and welding service business in Pleasantville. A 2006 Spring ETI graduate, Rose-Vony Duroseau, received \$20,000 in financing from the UCEDC to help open a law practice in Newark that primarily serves low- and middle-income clients. She currently serves as an instructor for the ETI program.

The Small Business Mentoring Program is the first large-scale, statewide, organized effort to help ETI students who have graduated and gone on to start or expand a small business. In addition, EDA and NJDA loan recipients are also eligible for mentoring services. The program is designed to improve their success rate by providing the regular contact with business mentors who provide the guidance to help them survive and grow. The program is supported by four sponsoring organizations – CBAC, the Hudson County Community College in Jersey City, the Regional Business Assistance Corporation in Trenton and the UCEDC in Union – which provide office space for one mentoring staff person with in-kind administrative support. Through the Business Mentoring Program, 218 small businesses are assisted annually with a total of approximately 1,600 contact hours aiding with credit issues, business plans, financing proposals, bookkeeping, management and personnel issues, marketing and product/service pricing.

Marketing

The EDA joined with the OEG on the development of a State business web portal and call center as much-needed tools for starting, operating or growing a business in New Jersey. Also, the EDA continues to widely market its programs to businesses, communities and organizations through various vehicles, including speaking engagements, participation in events, media outreach and paid advertising, as well as its website at www.njeda.com.

In 2007, EDA worked closely with OEG and Commerce Commission staff to develop a comprehensive, statewide marketing campaign to attract and retain business, which will launch in 2008.

Summary

For more than three decades, the EDA has been a catalyst for creating jobs and promoting economic growth in New Jersey. With a strong focus on the primary business sectors critical to the state's economy, the EDA works to meet the financial, technical assistance and real estate development needs of small and mid-size businesses.

As a result, the EDA has found tremendous success in achieving the intent of the Local-State Business Incentive Promotion Act and continues to explore new methods to utilize its existing programs to that end.

The EDA's authorizing statute provides broad powers and flexibility, which allow the Authority to respond to ever changing economic and market conditions and thereby, adapt its programs to meet the needs of businesses in a timely and effective manner.

The Local-State Business Incentive Promotion Act incorporates this same flexibility and encourages the EDA to be creative in structuring financing and establishing partnerships to retain existing businesses and attract new businesses in local communities and regions throughout the state.
